Exchange Coordinator Report – Gail Holmes

The Florida Club of Greater Orlando exchange from March 11-18, 2016 has 21 ambassadors–5 from Wisconsin, 1 from Milwaukee, 5 from Western Kentucky, 7 from Cincinnati, 2 from Lansing, MI, and 1 from Southwest MI. Nancy Brown, also a member of the Greater Orlando Club, is coordinating the Wisconsin group and will participate in the exchange.

The Cleveland County, England outbound exchange from May11-18, 2016 is full with 12 ambassadors and 10 participating in the Edinburgh, Scotland four-night extension. The Exchange Coordinator's advisory committee has approved George's application to be an Exchange Director and we now submit it to the Board for their approval.
